Appomattox Town Council Council Workshop Meeting October 23, 2018

The Appomattox Town Council held a Council Workshop meeting on Tuesday, October 23, 2018 at 7:00 p.m. at the Appomattox Municipal Building, 210 Linden Street, Appomattox, Virginia with Mayor Harvey, presiding.

Members present: Jonathan D. Garrett, James J. Boyce, Sr., Mary Lou Spiggle, Timothy W. Garrett and Claudia G. Puckette.

Absent: Steven T. Conner

Others present: Don Austin & Brian Casto, VDOT; Bif Johnson and Stacie Castro, Hurt & Proffitt, Inc.; Nathan Simpson, Nick Walton, Carlton duck, Susan Adams, County Administrator; Kim Ray, Town Treasurer; Gary Shanaberger, Town Manager and Roxanne W. Casto, Clerk of Council.

Mayor Harvey called the meeting to order.

<u>Smart Scale Project – Route 131 Roadside Improvements –</u>

Mr. Shanaberger introduced Don Austin and Brian Casto with VDOT to discuss the Smart Scale project – Route 131 Roadside Improvement project.

The costs to the Town will be for maintenance of lighting and location desired and types of landscaping. This information will better aid the Town in knowing how much funding will be needed in the future budget cycles. AECom will offer suggestions for lighting and landscaping for the Town's consideration. Mr. Boyce requested background information for this project. Mr. Casto, VDOT explained that the town submitted an application for the Smart Scale project. The project will be broken into three (3) phases. 1 – This presentation of Route 131, 2 – Roundabout on Confederate Blvd and Old Courthouse Road, 3 – Connector over the Route 24 bridge to tie together bridge with potential trails.

This is a street scape project that was scored based on merits. This project scored high for economic development, safety and pedestrian traffic/trails. The Smart Scale project is completely funded by VDOT. The Town will be responsible for maintenance of lighting and landscaping. There are no matching funds for the project. The town was very fortunate to receive this project. The application was great!

The goal of this meeting was to acknowledge the very early design phase and gain the Town's input on maintenance of landscaping and lighting. VDOT will continue to invite Mr. Shanaberger to each project meeting. The Preliminary Field Inspection is scheduled for early Spring 2019.

Council thanked the VDOT and AECom Representatives for sharing this update.

<u>Utility Rate Study –</u>

Mr. Bif Johnson, Hurt & Proffitt, Inc. discussed with Council the Rate Study scenarios. He presented neighboring community data and discussed the real difference between the flat vs.

tiered structure. The flat structure has the residential customers carrying the burden of the system at a rate of 56%. While the businesses are carrying 32%. The tiered structure would close the gap somewhat. Mr. Johnson also reminded Council that after the first increase, it is only 3% per year.

Mr. Johnson received questions from Council.

Mayor Harvey thanked Mr. Johnson and Ms. Castro for this additional information. This clarified this very well. It makes it more palatable.

Council thanked Mr. Johnson and Ms. Castro for attending the meeting.

Appomattox Magazine –

Mr. John Redding, President, Appomattox County Chamber of Commerce spoke to Council the Appomattox Magazine. The Chamber has distributed nearly all of the 3,200 copies from the first printing. The Chamber would like to apply for a Virginia Tourism Corporation (VTC) grant program. The Chamber would be the lead partner and the County of Appomattox has already agreed to partner and the Town appears to be the obvious choice. The minimum financial contribution is \$250.00. The grant application is due November 7, 2018. Mayor Harvey expressed support for \$1000 from the Town. Mrs. Puckette and Ms. Spiggle agreed to support the project at \$1,000.00. This is a better project than some received.

On a motion by Mrs. Puckette, seconded by Ms. Spiggle, Council voted to partner with Appomattox County and the Appomattox County Chamber of Commerce and provide \$1000 for the Appomattox Magazine.

Roll call vote: J. Garrett – yes, Boyce – yes, Spiggle – yes, T. Garrett – yes, Puckette – yes. Motion carried 5-0.

Town Manager's Report:

Mr. Shanaberger reported on the following:

- ➤ Train Depot Mr. Shanaberger reported that Dalgleish Gilpin Paxton Architects has been working hard on the train depot project. Dalgleish Gilpin Paxton Architects will meet with Council on December 10, 2018 to provide an update on the project as well as an updated timeline.
 - Mr. T. Garrett inquired if minutes were taken of the Community meeting held at the train depot? Mr. Shanaberger will ask Dalgleish Gilpin Paxton to provide their worksheets of that meeting to Council.
- Downtown Revitalization Project There will be a project management team meeting tomorrow, November 14, 2018 at 5:30 p.m. The public hearing is planned for December 10, 2018. The parking on that end of town continues to be explored and the possibility of using a portion of the grant for parking.
- ➤ Water & Sewer Backup (Incident) Policy Staff has been working on an Incident Policy for water and sewer backups. The policy has been reviewed by the Virginia Municipal League Insurance Programs and the Town Attorney. It will be presented to Town Council for consideration to adopt at the next meeting.
- ➤ Food Truck Ordinance The ordinance is nearly complete however he would like to have Council's input on fees and requirements.
- ➤ VDOT 2 way stop Mr. Elder and Mr. Shanaberger are looking at ways to lower the sidewalk on Harrell Street and Church Street behind Main Street and remove portion of the sidewalk railing. Business owners do not like the idea of one-way traffic on Harrell Street.

Council Concerns:

A possible referendum will be presented in May 2020 for 4-year terms of council members and Mayor. If it passes it would go to the General Assembly in 2021 with an effective date of July 1, 2021.

Ms. Spiggle wished everyone a blessed Thanksgiving with family and friends.
