INCIDENTS AND LIABILITY

Section 1. PURPOSE

The purpose of this document is to state the policy of the Town of Appomattox ("Town") with regard to incidents that impact private property. Incidents may include, but are not limited to, damages to property caused by sewer backups, sewer overflows, and water from ruptured waterlines.

Section 2. POLICY

After being informed of an incident, the Town will endeavor to take the following actions:

- A. The Town will investigate the incident to try to determine the cause of the incident.
 - 1. The Town will need access to the location where the damage occurred.
 - 2. The Town will investigate the causes of the backup, including the history of any prior problems of that section of the line where the backup took place.
 - 3. The Town will seek permission to enter the premises and photograph the damages; a form titled "Permission to enter premises and non-waiver of Defenses" must be signed prior to Town staff entering the property.
 - 4. Photographs will be taken, and a report will be prepared by the Town of the findings.
 - 5. The Town will inform the property owner that they have an affirmative duty to mitigate their damages, regardless of who may be at fault for causing said damages. This includes, but is not limited to, hiring a plumber and/or a mitigation company to perform cleanup services, as necessary; the Town will further strongly recommend that the property owner report the incident to their property owner's insurance carrier. The Town will not provide any plumbing or cleanup services, nor will they hire contractors to perform these services.
- B. If the damage was caused due to problems that occur in private facilities (customer service lines, customer laterals, etc.), the Town will report to the property owner that it will be the property owner's responsibility to correct the problems and repair the damages.
- C. If the damage was caused due to problems related to the systems under the control of the Town, the Town will report the incident to its liability insurance carrier for further investigation to determine legal liability, if any, as to the Town. It is the sole decision of the Town's liability insurance carrier to determine negligence on the part of the Town and whether they will compensate the property owner for damages occurred due to the incident.

Section 3. REVISIONS

A. This policy was approved and adopted by the Appomattox Town Council on $\underline{11/27/2018}$, effective $\underline{11/28/2018}$.
